1. Online Item rate e-tenders are hereby invited through the e-tendering portal "<https://etenders.gov.in/eprocure/app>" in two cover system, for the composite work(Civil + Electrical) "**Renovation of old PCBT laboratories at CSIR-CFTRI, Mysuru(CIVIL + ELECTRICAL)**" from the registered firms or contractors of appropriate class having worked with CPWD, Railways, MES, Post & Telegraph Department., State PWD's, Semi Government organizations or those who have successfully carried out works for CSIR or its laboratories. The tenderers should have successfully completed at least three similar works amounting to 40% or at least two similar works amounting to 60% or at least one work amounting to 80% or above in a single contract of the estimated cost of work as shown in NIT **during the last five years, ending on the last day on the month previous to the one in which tender is being invited.** The contractors may apply with proof of fulfilling the above conditions along with copies of PAN Card, GST registration number, valid firm's or contractor's registration of appropriate class, satisfactory work done certificates. The contractor will be required to produce proof of possessing valid Electrical license or to get the electrical work completed through licensed Electrical contractor only.
2. The Estimated cost of work is **Rs 29,04,676/- (Rupees Twenty Nine Lakh Four thousand Six hundred Seventy Six only)** based on CPWD, DSR-2016 (Including relevant current cost index) and prevailing market rates inclusive of GST. The Earnest Money Deposit (EMD) is **Rs 58,100.00 (Rupees Fifty Eight Thousand One Hundred Only)**. Duration of contract for carrying out of the work will be **60 days (Sixty Days)** from the date of commencement which shall be reckoned from the fifth day of issue of award letter.
