Online Item rate e-tender is invited through the e-tendering portal https://etenders.gov.in/eprocure/app in two cover system for the work "Replacement of damaged kitchen cabinet floor & wall tiles and connected Civil Works at CFTRI House, CSIR-**CFTRI, Mysuru**".
