The Director, CSIR-CFTRI, Mysuru invites applications from experienced Contractors/ Agencies/Firms for EXPRESSION OF INTEREST (EOI) for **“Upgradation of Microbiology lab and GM lab at FS&AQCL, CSIR-CFTRI to house unidirectional structured testing facility as per FSSAI guidelines on turnkey basis”** The details are below:

1. Experienced Contractors/ Agencies/Firms are requested to submit the EOI along with details of firm profile, firm registration certificate/Contractor's License , GST, PAN, technical expertise and details of completed **unidirectional structured testing facility/ clean room facility for Microbiology lab / GM Lab during the last five years, ending on the last day on the month previous to the one in which EOI is being invited at Government and Reputed Private Organizations with satisfactory completion certificate from the respective clients in the Cover.**
2. EOI shall be submitted through online at CPP Portal: <https://etenders.gov.in/eprocure/app> by the agency/firm. The instructions for the submission of EOI are available on the CPP portal i.e. <https://etenders.gov.in/eprocure/app> under the "Instruction for Online Bid Submission". All the intending agency/firm are requested to go through these instructions before submitting EOI and advised to visit again CPP Portal regularly till closing date of submission of EOI for any corrigendum/ addendum/ amendment. Manual EOI shall not be accepted. Critical Date Sheet is given below:

3. The EOI received from agencies/firms will be scrutinized and eligible agencies/firms will be short listed for technical presentation. After the presentation, technical specification will be prepared and open tender will be invited for both technical and financial bid in CPP Portal. The Director, CSIR-CFTRI reserves the right to accept in full or in part or reject all or any application without assigning any reasons whatsoever and no correspondence will be entertained in this regard.
4. The agencies/firms are to indicate the name & telephone numbers of issuing agency of the completion certificates to enable the verification of the documents, if necessary. It may be noted that even after opening of price bid, the credential submitted found to be false / forged the offer submitted shall be rejected out rightly. No further clarification will be sought from the tenderers.
5. No agencies/firms shall be permitted to apply for EOI/tender for works in the concerned unit of C.S.I.R. in which a relative is posted in the grade between Controller of Administration and Junior Engineer, (both inclusive). He shall also intimate the name of persons who are working with him in any capacity or subsequently employed by him and whose relatives are as mentioned above.
Note: A person shall be deemed to be a relative of another if, and only if, (a) they are members of a Hindu undivided family or (b) they are husband and wife or (c) the one is related to the other in the following manner: father, mother (including step mother), son (including step son), Son's wife, Daughter (including step daughter), Father's father, Son's son, Son's son's wife, Son's daughter, Son's daughter's husband, Daughter's husband, Daughter's son, Daughter's son's wife, Daughter's daughter, Daughter's daughter's husband, Brother (including step brother), Brother's wife, Sister (including step sister), Sister's husband. Relationship declaration should be submitted/uploaded in the cover I as per Annexure-B.
6. Before submitting EOI, the agencies/firms shall inspect the site to fully acquaint himself about the conditions of accessibility of site, nature and extent of ground, working condition of site and locality including stacking of materials, installations off tools and plants (T&P) etc., conditions affecting accommodations and movement of labour etc. required for the satisfactory execution of contract. No claim whatsoever on such accounts shall be entertained by the employer under any circumstances.
7. Not more than one EOI shall be submitted by one contactor or contractors having business relationship. Under no circumstance will father and his son(s) or other close relations who have business relationship with one another (i.e when one or more partner(s)/director(s) are common) be allowed to EOI for the same contract as separate competitors. A breach of this condition will render the EOI of both parties liable to rejection.
8. For any queries relating to the EOI Document and the terms and conditions content therein should be addressed to COA, CSIR-CFTRI, Mysuru.

9. EOI Liable for Rejection.

EOI is liable for outright rejection if on opening it is found that —

- (a) The agencies/firms have not strictly followed the procedure laid down for submission of EOI.
- (b) If the EOI is CONDITIONAL
- (c) The agencies/firms have not uploaded the documents or failed to fill the prescribed format.
- (d) Any other ground as decided by the TOC in view of deviation from EOI
