- 1. Online Expression of Interest (EoI) is invited through the e-tendering portal https://etenders.gov.in/eprocure/app in single cover system from the registered firms or contractors of appropriate class having successfully completed the similar works with CSIR and its laboratories, CPWD, Railways, MES, Post & Telegraph Department., State PWD's, Semi Government organizations to erect Pre Engineered Buildings (PEB-1, PEB-2 and PEB-3) to house "Centre of Excellence on Millets and Incubation Centre at CSIR CFTRI, Mysuru".
- Scope of work: Architectural & Structural Design, Drawings, Supply, Fabrication, Erection
 and Commissioning of three numbers of Pre Engineered Buildings (PEB-1, PEB-2 and
 PEB-3) including Civil and Electrical works at CSIR-CFTRI campus Mysore. The PLAN of all
 the three building is enclosed along with this for reference purpose only.

4. Documents to be submitted:

- a. Documentary evidences such as scope of work, successful completion and acceptance.
 - b. Company profile including organization chart.
 - c. Completion certificate issued by the concerned authority.
 - d. Certificate of registration of the firm / proprietorship.

Selection criteria for short listing:

- a. Based on the Annual turnover Annual turnover shall be at least 5.00 Crores for the past 3 years and shall be audited and certified by the Chartered Accountant.
- **b.** Similar work done certificate: Bidders should submit the work done certificate having at least **One** similar work mounting to 5.00 Crores or **Two** similar works amounting to Rs.3.75 Crores or **Three** similar works amounting to Rs.2.00 Crores.

- 5. Eol Submission: Eol shall be submitted through online at CPP Portal: https://etenders.gov.in/eprocure/app by the tenderer, as per date given in Critical Date Sheet below. The instructions for the submission of e-tender are available on the CPP portal i.e. https://etenders.gov.in/eprocure/app under the "Instruction for Online Bid Submission". All the intending tenderers are requested to go through these instructions before entering into the process of e-tendering of this work and advised to visit again CPP Portal regularly till closing date of submission of tender for any corrigendum/ addendum/ amendment.
- 6. The received documents of the bidders will be scrutinized and eligible bidders will be shortlisted. Further limited tender will be invited for technical and price bid from the short listed bidders through CPP Portal. The Director CSIR-CFTRI reserve the right to accept in full or in part or reject all application without assigning any reasons whatsoever and no correspondence will be made in this regard.
- 7. Work done / completion certificate shall contain name and telephone numbers of issuing authority to enable the verification of the documents if necessary. It may be noted that, even after opening the price bid, the credentials submitted found false / forged, theh offer submitted shall be rejected out rightly.
- 8. No tenderer shall be permitted to bid for EOI in the concerned unit of CSIR in which a relative is posted in the grade between Controller of Administration and Junior Engineer, (both inclusive). He shall also intimate the name of persons who are working with him in any capacity or subsequently employed by him and who relatives are as mentioned above.

(A person shall be deemed to be a relative of another if, and only if, (a) they are members of a Hindu undivided family or (b) they are husband and wife or (c) the one is related to the other in the following manner: father, mother (including step mother), son (including step son), Son's wife, Daughter (including step daughter), Father's father, Son's son, Son's son's wife, Son's daughter, Son's daughter's husband, Daughter's husband, Daughter's son, Daughter's son's wife, Daughter's daughter, Daughter's daughter's husband, Brother (including step brother), Brother's wife, Sister (including step sister), Sister's husband.)

- 9. Not more than one tender shall be submitted by one contactor or contractors having business relationship. Under no circumstance will father and his son(s) or other close relations who have business relationship with one another (i.e when one or more partner(s)/director(s) are common) be allowed to tender for the same contract as separate competitors. A breach of this condition will render the tenders of both parties liable to rejection.
- 10. Tender / Eol is Liable for Rejection.

Eol is liable for outright rejection if on opening it is found that —

- (a) The EoI has not strictly followed the procedure laid down for submission of tender.
- (b) If the EoI is CONDITIONAL
- (c) If the EoI has quoted his offer anywhere else other than specified place provided.

- (d) The EoI has not uploaded the documents or Failed to fill the prescribed format.
- (e) Any other ground as decided by the TOC in view of deviation from Tender Document.
