Online e-tender is Item rate invited through the e-tendering portal https://etenders.gov.in/eprocure/app in two cover system from the eligible contractors for the work "Renovation (civil and electrical) of old ECC stores building adjacent to Main Mansion at CSIR-CFTRI, Mysore". The tenderers should have successfully completed at least three similar works amounting to 40% or at least two similar works amounting to 60% or at least one work amounting to 80% or above in a single contract of the estimated cost of work as shown in NIT during the last five years, ending on the last day on the month previous to the one in which tender is being invited. The contractors may apply with proof of fulfilling the above conditions along with copies of PAN Card, GST registration number, valid firm's or contractor's registration of appropriate class and satisfactory work done certificates from the any Govt/Govt undertaking departments. The contractor will be required to produce proof of possessing valid Electrical license or to get the electrical work completed through licensed Electrical contractor only if any (Please see Page no 7 of Tender documents).

Similar work: Construction of buildings or renovation of buildings. Work done certificates of any other nature of work will not be accepted in this regard.

The Estimated cost of work is Rs 50,82,510/- (Rupees Fifty Lakh Ninety Eighty Two Thousand Five Hundred Ten Only) based on CPWD, DSR-2023 (Including relevant current cost index), prevailing market rates and inclusive of GST. The Earnest Money Deposit (EMD) is Rs.1,02,000.00 (Rupees One Lakh Two Thousand). Duration of contract for carrying out of the work will be 60 days (Sixty Days) including all seasons from the date of commencement which shall be reckoned from the fifth day of issue of award letter.
