- 1. Online Item rate e-tender is hereby invited through the e-tendering portal "https://etenders.gov.in/eprocure/app" in two cover system, for Civil and Electrical work "Renovation of HRD Block (Civil+ Electrical) at First floor of SRP building, CSIR-CFTRI, Mysuru" from the registered firms or contractors of appropriate class having worked with CPWD, Railways, MES, Post & Telegraph Department., State PWD's, Semi Government or Government organizations or those who have successfully carried out works for CSIR or its laboratories .The tenderers should have successfully completed at least three similar works amounting to 40% or at least two similar works amounting to 60% or at least one similar work amounting to 80% or above in a single contract of the estimated cost of work as shown in NIT during the last five years, ending on the last day on the month previous to the one in which tender is being invited. The similar works here refers to the renovation of buildings or construction of buildings. The contractors shall apply with proof of fulfilling the above conditions along with copies of PAN Card, GST registration certificate, valid firm's or contractor's registration certificate of appropriate class, satisfactory work done certificates from the respective clients, tender acceptance letter, relationship declaration etc. The contractor shall produce proof of possessing valid Class 1 Electrical License of the Contractor or Class 1 Electrical license of sub-**Contractor** engaged for the execution of electrical nature of work by the main firm / contractor.
- 2. The Estimated cost of work is Rs. 77,30,874/- (Rupees seventy-seven lakhs thirty thousand eight hundred and seventy-four only) based on CPWD, DSR-2023(Civil) and 2022(Electrical) (Including relevant current cost index) and prevailing market rates inclusive of GST and labour cess. The Earnest Money Deposit (EMD) is Rs. 1,54,650/- (One lakh fifty-four thousand and six hundred and fifty only). Duration of contract for carrying out of the work will be 120 days (One hundred and twenty days) including all seasons from the date of commencement which shall be reckoned from the fifth day of issue of award letter.
- 3. **Bid Submission:** Bids shall be submitted through online at CPP Portal: https://etenders.gov.in/eprocure/app by the tenderer, as per date given in Critical Date Sheet below. The instructions for the submission of e-tender are available on the CPP portal i.e. https://etenders.gov.in/eprocure/app under the "Instruction for Online Bid Submission". All the intending tenderers are requested to go through these instructions before entering into the process of e-tendering of this work and advised to visit again CPP Portal regularly till closing date of submission of tender for any corrigendum/ addendum/ amendment. Manual tenders shall not be accepted.
