1. Online Item rate tenders are hereby invited through the e-tendering portal "<https://etenders.gov.in/eprocure/app>" in two cover system, for the Electrical work **"New Electrical + Civil Requirements at Building 3 of CoE MIC, for housing Biodegradable, Edible Processing Units etc., from FMBCT Department at CSIR-CFTRI, Mysuru"** from the registered firms or contractors of appropriate class having worked with CPWD, Railways, MES, Post & Telegraph Department., State PWD's, Government or Semi Government organizations or those who have successfully carried out works for CSIR or its laboratories. The tenderers should have successfully completed at least three similar works (Electrical + Civil) amounting to 40% or at least two similar works amounting to 60% or at least one similar work amounting to 80% or above in a single contract of the estimated cost of work as shown in this NIT **during the last five years, ending on the last day on the month previous to the one in which tender is being invited** . The contractors may apply with proof of fulfilling the above conditions along with copies of **PAN Card, GST registration number, valid firm's or contractor's registration of appropriate class, satisfactory work done certificates, valid Electrical contractor and supervisory license**.
2. The Estimated cost of work is **Rs.18,89,678.00 (Rupees Eighteen Lakhs Eighty-Nine Thousand Six Hundred and Seventy-Eight Only)** based on CPWD DSR Electrical 2022 and prevailing Market Rates. The Earnest Money Deposit (EMD) is **Rs. 38,000/- (Rupees Thirty-Eight Thousand Only)**. Duration of contract for carrying out of the work will be **60 Days (Sixty Days)** from the date of commencement which shall be reckoned from the fifth day of issue of award letter .
3. **Bid Submission:** Bids shall be submitted through online at CPP Portal: <https://etenders.gov.in/eprocure/app> by the tenderer, as per date given in Critical Date Sheet below.
