Online Item rate e-tender is invited through the e-tendering portal <https://etenders.gov.in/eprocure/app> in two cover system from the eligible contractors for the work "Relaying of damaged road from MMS department to E&MM department at CSIR - CFTRI, Mysore". The tenderers should have successfully completed at least three similar works amounting to 40% or at least two similar works amounting to 60% or at least one work amounting to 80% or above in a single contract of the estimated cost of work as shown in NIT during the last five years, ending on the last day on the month previous to the one in which tender is being invited. The contractors may apply with proof of fulfilling the above conditions along with copies of PAN Card, GST registration number, valid firm's or contractor's registration of appropriate class, satisfactory work done certificates. The contractor will be required to produce proof of possessing valid Electrical license or to get the electrical work completed through licensed Electrical contractor only if any.
2. The Estimated cost of work is **Rs 13,65,647/- (Rupees Thirteen Lakh Sixty Five Thousand Six Hundred Fourty Seven Only)** based on CPWD, DSR-2021 (Including relevant current cost index), prevailing market rates and inclusive of GST. The Earnest Money Deposit (EMD) is **Rs.27,350.00 (Rupees Twenty Seven Thousand Three Hundred Fifty Only)**. Duration of contract for carrying out of the work will be **45 days (Fourty Five Days)** including all seasons from the date of commencement which shall be reckoned from the fifth day of issue of award letter.
