<u>Specifications and Allied Technical Details for Supply and Installation of Small Animal Live Imaging System</u>

4.1 End Use: Research and Development

4.2 Detailed Technical Specifications for Small Animal Live Imaging System

<u>Technical Specification (After pre-bid meeting) for Small Animal Live Imaging System for CSIR-CFTRI, Mysuru.</u>

1. Recommendations on equipment's Applications

The small animal live imaging system should be fully automatic, integrated (preferable) and capable to perform following applications in both Rats and Mice;

- a. 2D Bioluminescence
- b. 2D Fluorescence (filters ranges up to 400nm to 900nm)
- c. 2D Chemiluminescence
- d. 2D X-ray / Ultra High Resolution Micro CT
- e. Radio isotopic studies for *in-vivo* and *in-vitro* use (Cerenkov imaging)

2. Recommendations on equipment's technical specifications under each application

The animal live imaging system should have following specifications for the R&D applications of CSIR-CFTRI

- 1. Light proof/tight cabinet.
- 2. High quality back illuminated CCD camera with at least 4.0 mega pixel resolution and at least -90°C cooled CCD for higher resolution, with Pixel Size 13.5 microns, Minimum Read Noise (e-) < 3.8 electrons for bin 1-16 for low signal detection.
- 3. Sample stage: Stage temperature should be controllable between 20°C to 40°C. Stage movement should be software controlled for different levels of magnifications. System must have high throughput capability with at least 5 animal imaging simultaneously to reduce hand-on time on device.
- 4. Computer work station with all the accessories as in Sl no. 17.
- 5. Compulsory Gas Anaesthesia system to be provided with the imaging station, including 2 numbers of relevant gas cylinders, regulators and accessories from either principal or third party suppler.
- 6. The system should have tungsten halogen/ LED/xenon light source with extended range till NIR with broad range of excitation and emission filters for the larger end-user applications, a minimum of 18 excitation ranging from 410 nm to 790 nm with a bandwidth of 20 nm and 7 emission filters ranging from 500 nm to 860 nm with a narrow bandwidth of 40 nm is a must. The Excitation and emission filter wheels should be motorized and software controlled. Flexibility of using upto 5 optical reporters simultaneously inside the same animal is a must.
- 7. The Field of View of imaging should be 10 x 10, 15 x 15 and 20 x 20 cm for both optical & X-Ray/ Ultra High Resolution Micro CT imaging with image overlay feature for colocalization.
- 8. Quantum efficiency: >85% for 500 nm 700 nm range.
- 9. System should have X-Ray/<u>Ultra High Resolution Micro CT</u> with minimum spatial resolution of 21 lines/mm or higher.
- 10. Image acquisition and analysis software suitable for fluorescence, bioluminescence and Cerenkov studies for in-vivo and in-vitro studies in both animal as well as plant system (culture dishes & well plate formats) in a single software.
- 11. System must have multiple angle projections of 360° rotation for both optical & X-ray imaging/Ultra high resolution micro CT imaging, with image overlay feature for more than 12 angles.

- 12. Software should be able to spectrally unmix multiple reporters (at least 5) within same animal based on pure spectrum extraction algorithm and should be able to generate spectral library.
- 13. Radiation Shielded Cabinet should Exceed standards set by the U.S. FDA Center for Devices and Radiological Health (21 CFR 1020.40).
- 14. Gas anaesthesia ports and 5 position manifold with gas flow controller should be supplied. Complete working configuration inclusive of hardware/software, tubing, valves, should be supplied.
- 15. System must have minimum 5 similar installations in within India. Letter of appreciation/satisfaction should be provided from each end user from India.
- 16. The company should have complete reagent & cell line support required for *in vivo* experiments; preoptimized on the instrument. Minimum five applications from Oncology, Angiogenesis, inflammation, MMPase activity, Neutrophil Elastase, arthritis, Hypoxia, vascular leak, bone and brain imaging with published literature must be provided.
- 17. Latest computer configuration compatible with system hardware and software should be provided. Licensed operating system, 22 inch LED high resolution monitor, 8th generation i7 processor, 4 TB HDD, 32 GB RAM, with graphic card of not less than 4 GB. Software shall be upgraded free for life time. Branded colour printer to be provided by the supplier.
- 18. The system should come with 1-year warranty and 2-years CMC to be provided after completion of warranty period.
- 19. Suitable vibration free heavy-duty table should be provided by the supplier at the time of installation.
- 20. 3KVA online UPS with 30 mins backup for the instrument should be provided by the supplier.
- 21. Phantom to be included for practice and training on optical imaging with multiple wavelength selection. The phantom should mimic the animal body.
- 22. The Image/video acquisition and post run analysis software support should be free with free updates till the life of the equipment.
- 23. Optimized protocols for each application like oncology, angiogenesis, inflammation, MMPase activity, neutrophil elastase, arthritis, hypoxia and vascular leak, bone and brain imaging with publications\references in reputed journals should be made available in the technical bid. The hard copy of the same should be provided as booklets at the time of installation.
- 24. Hard copies of Protocols\Methodologies for different therapeutic areas should be provided at the time of installation in the form of a booklet.
- 25. Free visit to installation site for any technical help on demand by the end user during the Warranty and CMC period unlimited number of times.
- 26. Complementary cell lines\dyes or tags for start-up work to be provided at the time of installation.
- 27. All the requirements including tags\dyes etc. to be provided for the demonstrations post installation.

4.3 Scope of Supply and incidental works: Scope of Supply includes the following:

- I. Supply of the equipment / system along with the accessories.
- II. Installation, Commissioning and Acceptance by the end user
- III. Training as specified in tender
- IV. On site comprehensive Warranty as specified in SCC
- V. Annual Maintenance Contract / Maintenance Support as specified in BoQ
- VI. Delivery Schedule as specified in SCC

4.4.2 Manufacturer's Inspection Certificate

After the goods are manufactured and assembled, inspection and testing of the goods shall be carried out at the supplier's facility by the supplier, prior to shipment to check whether the goods are in conformity with the technical specifications. Manufacturer's test certificate with data sheetshall be issued to this effect and submitted along with the delivery documents. The purchaser reserves the options to be present at the supplier's premises during such inspection and testing.

4.4.3 Installation, Commissioning and Acceptance Test

The acceptance test will be conducted by the Purchaser, their consultant or other such person nominated by the Purchaser at its option after the equipment is installed at Purchaser's site in the presence of supplier's representatives. The acceptance will involve trouble free operation. There shall not be any additional charges for carrying out acceptance test. No malfunction, partial or complete failure of any part of the equipment is expected to occur. The Supplier shall maintain necessary log in respect of the result of the test to establish to the satisfaction of the Purchaser, the successful completion of the test specified.

On the event of the ordered item failing to pass the acceptance test, a period not exceeding two weeks will be given to rectify the defects and clear the acceptance test, failing which, the Purchaser reserve the right to get the equipment replaced by the Supplier at no extra cost to the Purchaser.

Successful conduct and conclusion of the acceptance test for the installed goods and equipment shall also be the responsibility and at the cost of the Supplier.

- ▶ If the Bidder fails to enclose the compliance statement, his bid is likely to be rejected.

Format of Integrity Pact

INTEGRITY PACT

Council of Scientific & Industrial Research (CSIR) a Society registered 1860 represented by	
Andherein referred to as "The Bido	ler/ Contractor."
Preamble	
The Principal intends to award, under laid down organizatiThe Principal values full compliance with	•
regulations, economic use of resources and of fairness/ transparen and/or Contractor(s).	

In order to achieve these goals, the Principal will appoint an Independent External Monitor (IEM), who will monitor the tender process and the execution of the contract for compliance with the principles mentioned above.

Section 1 - Commitments of the Principal

Between

- (1) The Principal commits itself to take all measures necessary to prevent corruption and to observe the following principles:
- (a) No employee of the Principal, personally or through family members, will in connection with the tender for, or the execution of a contract, demand, take a promise for or accept, for self or third person, any material or immaterial benefit which the person is not legally entitled to.
- (b) The Principal will, during the tender process treat all Bidder(s) with equity and reason. The Principal will in particular, before and during the tender process, provide to all Bidder(s) the same information and will not provide to any Bidder(s) confidential/additional information through which the Bidder(s) could obtain an advantage in relation to the tender process or the contract execution.
- (c) The Principal will exclude from the process all known prejudiced persons.
- (2) If the Principal obtains information on the conduct of any of its employees which is a criminal offence under the IPC/PC Act, or if there be a substantive suspicion in this regard, the Principal will inform the Chief Vigilance Officer and in addition can initiate disciplinary action.

Section 2 – Commitments of the Bidder(s)/Contractor(s)

- (1) The Bidder(s)/Contractor(s) commit himself to take all measures necessary to prevent corruption. He commits himself to observe the following principles during his participation in the tender process and during the contract execution.
- (a) The Bidder(s)/Contractor(s) will not, directly or through any other Person or firm, offer, promise or give to any of the Principal's employees involved in the tender process or the execution of the

contract or to any third person any material or other benefit which he/she is not legally entitled to, in order to obtain in exchange any advantage of any kind whatsoever during the tender process or during the execution of the contract.

- (b) The Bidder(s)/Contractor(s) will not enter with other Bidders into any undisclosed agreement or understanding, whether formal or informal. This applies in particular to prices, specifications, Certifications, subsidiary contracts, submission or non-submission of bids or any other actions to restrict competitiveness or to introduce cartelization in the bidding process.
- (c) The Bidder(s)/Contractor(s) will not commit any offence under the relevant IPC/PC Act; further the Bidder(s)/Contractor(s) will not use improperly, for purposes of competition or personal gain, or pass on to others, any information or document provided by the Principal as part of the business relationship, regarding plans, technical proposals and business details, including information contained or transmitted electronically.
- (d) The Bidder(s)/Contractor(s) of foreign origin shall disclose the name and address of the Agents/representatives in India, if any. Similarly the Bidder(s)//Contractors(s) of Indian Nationality shall furnish the name and address of the foreign principals, if any. Further details as mentioned in the "Guidelines on Indian Agents of Foreign Suppliers" shall be disclosed by the Bidder(s)/Contractor(s). Further, as mentioned in the Guidelines all the payments made to the Indian agent/representative have to be in Indian Rupees only. Copy of the "Guidelines on Indian Agents of Foreign Suppliers" is annexed and marked as Annexure.
- (e) The Bidder(s)/Contractor(s) will, when presenting his bid, disclose any and all payments he has made, is committed to or intends to make to agents, brokers or any other intermediaries in connection with the award of the contract.
- (2) The Bidder(s)/Contractor(s) will not instigate third persons to commit offences outlined above or be an accessory to such offences.
- (3) The persons signing IP shall not approach the courts while representing the matters to IEMs and he / she will await their decision in the matter.

Section 3 - Disqualification from tender process and exclusion from future Contracts

(1) If the Bidder(s)/Contractor(s), before award or during execution has committed a transgression through a violation of Section 2, above or in any other form such as to put his reliability or credibility in question, the Principal is entitled to disqualify the Bidder(s)/Contractor(s) from the tender process or take action as per the procedure mentioned in the "Guidelines on Banning of business dealings". Copy of the "Guidelines on Banning of business dealings" is annexed and marked as Annex - "B".

Section 4 – Compensation for Damages

- (1) If the Principal has disqualified the Bidder(s) from the tender process prior to the award according to Section 3, the Principal is entitled to demand and recover the damages equivalent to Earnest Money Deposit/ Bid Security.
- (2) If the Principal has terminated the contract according to Section 3, or if the Principal is entitled to terminate the contract according to Section 3, the Principal shall be entitled to demand and recover from the Contractor liquidated damages of the contract value or the amount equivalent to Performance Bank Guarantee.

Section 5 – Previous transgression

- (1) The Bidder declares that no previous transgressions occurred in the last 3 Years with any other Company in any country conforming to the anti-corruption approach or with any other Public Sector Enterprise in India that could justify his exclusion from the tender process.
- (2) If the Bidder makes incorrect statement on this subject, he can be disqualified from the tender process or action can be taken as per the procedure mentioned in "Guidelines on Banning of business dealings."

Section 6 - Equal treatment of all Bidders / Contractors/ Sub-contractors

- (1) The Bidder(s)/Contractor(s) undertake(s) to demand from all Subcontractors a commitment in conformity with this Integrity Pact, and to submit it to the Principal before contract signing.
- (2) The Principal will enter into agreements with identical conditions as this one with all Bidders, Contractors and Subcontractors.
- (3) The Principal will disqualify from the tender process all bidders who do not sign this Pact or violate its provisions.

Section 7 – Criminal charges against violating Bidders / Contractors/ Subcontractors

(1) If the Principal obtains knowledge of conduct of a bidder, Contractor or Subcontractor or of an employee or a representative or an associate of a bidder, Contractor or Subcontractor which constitutes corruption, or if the Principal has substantive suspicion in this regard, the Principal will inform the same to the Chief Vigilance Officer.

Section 8 - Independent External Monitors

- (1) The Principal appoints competent and credible Independent External Monitor for this Pact. The task of the Monitor is to review independently and objectively, whether and to what extent the parties comply with the obligations under this agreement.
- (2) The Monitor is not subject to instructions by the representatives of the parties and performs his functions neutrally and independently. He reports to the JS (A), CSIR.
- (3) The Bidder(s)/Contractor(s) accepts that the Monitor has the right to access without restriction to all Project documentation of the Principal including that provided by the Contractor. The Contractor will also grant the Monitor, upon his request and demonstration of a valid interest, unrestricted and unconditional access to his project documentation. The same is applicable to Subcontractors. The Monitor is under contractual obligation to treat the information and documents of the Bidder(s)/ Contractor(s) / Subcontractor(s) with confidentiality.
- (4) The Principal will provide to the Monitor sufficient information about all meetings among the parties related to the Project provided such meetings could have an impact on the contractual relations between the Principal and the Contractor. The parties offer to the Monitor the option to participate in such meetings.
- (5) As soon as the Monitor notice, or believes to notice, a violation of this agreement, he will so inform the Management of the Principal and request the Management to discontinue or take

corrective action, or to take other relevant action. The monitor can in this regard submit non-binding recommendations. Beyond this, the Monitor has no right to demand from the parties that they act in a specific manner, refrain from action or tolerate action.

- (6) The Monitor will submit a written report to the JS(A), CSIR within 8 to 10 weeks from the date of reference or intimation to him by the Principal and should the occasion arise, submit proposals for correcting problematic situations.
- (7) Monitor shall be entitled to compensation on the same terms as being extended to/provided to Independent Directors on the CSIR.
- (8) If the Monitor has reported to the JS(A), CSIR, a substantiated suspicion of an offence under relevant IPC/PC Act, and the JS(A), CSIR has not, within the reasonable time taken visible action to proceed against such offence or reported it to the Chief Vigilance Officer, the Monitor may also transmit this information directly to the Central Vigilance Commissioner.
- (9) The word 'Monitor' would include both singular and plural.

Section 9 – Pact Duration

This Pact begins when both parties have legally singed it. It expires for the Contractor 10 months after the last payment under the contract, and for all other Bidders 6 months after the contract has been awarded.

If any claim is made/lodged during this time, the same shall be binding and continue to be valid despite the lapse of this pact as specified above, unless it is discharged/determined by JS(A), CSIR.

Section 10 - Other provisions

- (1) This agreement is subject to Indian Law. Place of performance and Jurisdiction is the Registered Office of the Principal, i.e. New Delhi
- (2) Changes and supplements as well as termination notices need to be made in writing. Side agreements have not been made.
- (3) If the Contractor is a partnership or a consortium, this agreement must be signed by all partners or consortium members.
- (4) Should one or several provisions of this agreement turn out to be invalid, the remainder of this agreement remains valid. In this case, the parties will strive to come to an agreement to their original intentions.
