Online Item rate tenders are hereby invited through the e-tendering portal "<https://etenders.gov.in/eprocure/app>" in two cover system, for the Electrical work " **Scrapping and Painting of existing HT/LT distribution panels in the Institute premises of CSIR-CFTRI, Mysore.**" from the registered firms or contractors of appropriate class having worked with CPWD, Railways, MES, Post & Telegraph Department., State PWD's, Government or Semi Government organizations or those who have successfully carried out works for CSIR or its laboratories. The tenderers should have successfully completed at least three similar works amounting to 40% or at least two similar works amounting to 60% or at least one similar work amounting to 80% or above in a single contract of the estimated cost of work as shown in this NIT **during the last five years, ending on the last day on the month previous to the one in which tender is being invited.** Tenders from Reputed Panel Builders will also be accepted for this specialized nature of work who have supplied panels in CSIR Labs. The contractors may apply with proof of fulfilling the above conditions along with copies of **PAN Card, GST registration number, valid firm's or contractor's registration of appropriate class, satisfactory work done certificates, valid Electrical contractor and supervisory license or Company registration certificate of Reputed Panel Builders who have supplied panels in Government organizations/CSIR Labs**
2. The Estimated cost of work is **Rs. 01,75,000.00 (Rupees One Lakh Seventy Five Thousand only)** based on CPWD DSR-2018 (Including relevant current cost index) and prevailing market rates inclusive of GST. Duration of contract for carrying out of the work will be **30 days (Thirty Days)** from the date of commencement which shall be reckoned from the fifth day of issue of award letter.

3. **Bid Submission:** Bids shall be submitted through online at CPP Portal: <https://etenders.gov.in/eprocure/app> by the tenderer, as per date given in Critical Date Sheet below.
