2. The acceptance of the quotation will rest with the competent authority of CSIR-CFTRI, Mysuru, who does not bind himself to accept the lowest quotation and reserves the right to himself to reject, or partially accept any or reject all the quotations received without assigning any reasons thereof.
3. Your offer shall be valid for ninety days from the date of opening of the quotations. No revision in price will be allowed after opening the quotation.
4. **Prices are required to be quoted as indicated in the enquiry above, Discount and any statutory levy should be indicated and uploaded at the appropriate cover along with the technical bid. Please quote **final offer in the mandatory BOQ, XLS format may please be uploaded against the tender**.**
5. Conditional/Unsigned tenders shall not be considered.
6. The Comprehensive AMC and AMC for network switches is for 2 years. However, P.O will be issued for 1st year. P.O will be issued for 2nd year subject to satisfactory and necessary approval.

- e) Remote NOC resources for support should be experienced and trained enough for providing necessary support and troubleshooting.
- f) Weekly & Monthly Call summary reports should be shared.
- g) Quarterly business review should be conducted with CFTRI
- h) Quarterly visit should be done and network health to be verified and report to be submitted.

- j) Standby device for the faulty device to be provided within 24 hours.**
